VISIT TO AKRON CSD. Although I have visited each school district in Erie County as the Executive Director of ECASB, I had the opportunity to attend the Akron CSD Board of Education meeting on Wednesday night to present the Ray Carr Emerging Leaders Award to Board Member Kristy Pingitore. Kristy in her second year served as the district's Legislative Representative, served on the Education Committee for the BPO, the Education Committee for WNED/PBS, as well as serving on the planning and presentation team for the Legislative Dinner this past year. While attending the meeting, I ran into Mr. Paul Kowalski who I worked with at Lockport where he served as an Assistant Principal. He is currently the Technology Director and will become the next Business Administrator at Akron CSD. I also ran into Mr. John Morello who was appointed as the Assistant Principal and Athletic Director at Akron. I had the pleasure of having John in my art class at Lockport High School years ago....he looks the same, however he has a southern accent having lived in South Carolina for quiet a few years.

RE-ORGANIZATION MEETINGS: The next week and 1/2 School Boards will be holding their reorganization meetings. At the reorganization meeting, school boards will select representatives for the Delegate Assembly, the Legislative Committee and the Budget and Finance Committee. In addition, alternates will also be selected. District Clerks have been provided with job descriptions for each of the committees. Additionally, the dates have been indicated in the forms for the meetings. Almost ALL ECASB events and meetings are held on Thursday evenings. Only two districts within Erie County have Thursday night meetings. When establishing the ECASB calendar of events and meetings, we attempted out best to review Lackawanna City School District and the Alden School Districts meeting schedule to avoid as many conflicts as possible. On occasion, a school board does not select a representative for a committee. ECASB will as they have in the past, list the Board President as the default individual so that information is sent to district.

<u>ECASB CALENDAR OF EVENTS</u>: The Executive Board met last evening to finalize the 2024-2025 calendar. The Desk Card Calendar will now be sent to the printer and will be sent to district clerks to be distributed to all School Board Members and Superintendents.

NEW ECASB EVENT: A new ECASB event will be on September 26th. Mark your calendars. The event is a dinner designed for ALL NEW SCHOOL BOARD MEMBERS WITH less than 2 years of Board Service. We would ask that Superintendents and the Board Presidents also attend the event and accompany their new board members. If the Board President is unable to attend the event, we would ask for another Board Member that is a leadership position or an experienced Board Member attend the event. The event titled "Now that You Are Seated" will help answer many questions that new Board of Education members have to help guide them through Board Service. The dinner is being held in September to allow new School Board members to get a few Board Meetings under their belt. More information will be provided in the future. The program was developed based on feedback from ECASB members about providing more support for New School Board Members to better help prepare them and guide them for Board of Education service.

BUFFALO BUSINESS FIRST HAS RELEASED THEIR 2024 SCHOOLS GUIDE: The guide shows the entire snapshot of the district at a point in time. Schools will often use the Business First Guide as marketing tool. Often times, Business First will look at NYSED data. This year, they reviewed data from Niche.com The company is a Pittsburgh based company that compiles data from across the United States. Data was purchased on schools from Chautauqua, Cattaraugus, Erie, Niagara, and Genesee counties for comparison purposes. Watch for more information on the Business First Guide.

SOCIAL MEDIA BILL: Governor Kathy Hochul signed the "Stop Addictive Feeds Exploitation (SAFE) for Kids and The New York Child Data Protection Acts". The bill will:

- Limit the access that social media companies algorithmic or 'addictive' feeds have to minors.
- Require parental consent for minors to access algorithmic feeds on social media platforms.
- Require parental consent for minors to access social media platforms between 12:00 a.m. and 6:00 a.m. and get notifications during that time.
- -Authorize the Office of the Attorney General to seek damages for civil penalties for violations up to \$5,000 per violation.
- Allow parents/guardians of covered minors to sue for damages up to \$500 per incident, or actual damages.
- Prohibits online platforms for collecting, using, sharing, or selling personal data of anyone under the age of 18 for advertising, unless they received informed consent.
 - For users under the age of 13, this informed consent must come from a parent or guardian.

PRIVATE AND CHARTER SCHOOL STUDENTS NOT ENTITLED TO TRANSPORTATION ON DAYS SCHOOL DISTRICTS NOT IN SESSION: On June 20, 2024, New York's highest court confirmed that school districts (outside of New York City) are not required to provide transportation on days their schools are not in session. Complete questions should be directed to your legal counsel.

<u>QUESTION OF THE WEEK</u>: Inquiring School Board Members want to know... "How can school board members advocate with their elected officials during the summer?" Answer: Although elected officials may have a lighter schedule during the summer months most legislators and their staff would be available to meet with constituents in their local office. If you have a family with young children, and

your legislator is going to be in Albany, you could set up a meeting with them in Albany and arrange to tour historic Albany. One of the advantages of advocating during the summer months is that there may be less people vying for the legislators attention. When meeting with them, always leave with an 'ask'. If you need to provide any facts and figures on your district, reach out to your Superintendent and or Business Administrator.

NYSSBA AREA 1 DIRECTOR NEWS AND NOTES:

- Consider signing up for the Leadership in Education to be held in Albany at the Crowne Plaza Albany on July 19th and 20th. Why? Because EVERY district will be put to the test in the coming year. Will your school district be prepared?
- NYSSBA Board of Directors nominated for election, the following directors to serve as officers for a one year term beginning January 1, 2025: President-Sandra Ruffo; 1st Vice President-Chris Schnars, 2nd Vice President-Rodney George; and Treasurer-Tom Nespeca.
